



## Doss Celebrates 150th Anniversary

The town of Doss celebrated their 150th anniversary with the 83rd Annual Doss Fair. Among other events, they cooked and sold some great beef, chicken, and mutton BBQ, held a silent auction for home baked goods, acted a series of skits depicting the history of Doss, and ended the day with a series of comedy skits, monologues, and songs.

Edna Crenwelge, who authored the historical portion of the evening presentation, and Joe Schaefer, a newcomer to the area, took turns reading the history of Doss, while various citizens of the area acted out the history being described.

Originally, there was the land, as Mrs. Crenwelge stated, created by God and all his glory, populated by the occasional Apache, Comanche, and Texas Indians.

One of the Indian skits was a song about an Indian maid named Red Wing, portrayed by Loren Wendel of Fredericksburg. The song went

something like this:

There once lived an indian maid  
A shy little prairie maid  
Who sang all day, a love song gay  
As on the plain she'd while away the day  
She loved a warrior bold  
This shy little maid of old  
But brave and gay, he rode one day  
To battle far away

She watched for him day and night  
she kept her camp fires bright  
and under the sky each night she would lie  
and dream about his coming by and by

But when all the braves returned  
the heart of Red Wing yearned  
for far far away her warrior gay fell bravely in the fray

Chorus

Now, the moon shines tonight on pretty Red Wing

The breeze is sighing,  
the night bird's crying  
For afar 'neath his star her brave is sleeping  
While Red Wing's weeping her heart away

Mrs. Crenwelge's narration continued: in the 1870s the Texas Rangers rounded up the Indians and moved them onto reservations.

We read the following paragraphs in *The History of Doss, Texas 1856-1998* (published by Doss Community Improvement Club, August 1998).

From the top of Brockman's Point, Indian Peak and Nixon Point, the sharp-eyed braves could spy over the entire valley where the Onion Creek enters the Threadgill there is a rock shelter known as Indian Cave. It was here that the Comanches, after their frequent raids on moonlight nights, retreated until morning. Hundreds of arrow points and other souvenirs that Indians left at their camping and burial grounds have been found here. The cliff and overhanging rock came to be covered with Indian pictographs. All these symbols and signs had a meaning, either to serve as a record of events or a warning to other bands of Indians wandering

that way In 1947, geology students of the University of Texas dug in the cave and found a skeleton of an Indian, a few beads, and several arrows. This all can now be seen at the University Museum at Austin, Texas.

ers," it appears that Doss, Texas, was founded by the Doss brothers, after whom it was named, and that the point of founding of the community was the mill on the Threadgill and that the date was 1856.

The first records of the Doss brothers in Gillespie County records are for the year 1852. Mention is made, however, in one record of their partnership existing since 1851.

Thomas C. Doss seems to have been most interested in the town of Fredericksburg at the beginning. In 1852, he purchased several lots and outlots in and near the city, some of them from the German Emigration Co.

His brother, John E. Doss, on the other hand, seems to have turned his hand to ranching and farming east of Fredericksburg. He began his purchases in 1854 by acquiring 800 acres of what is now the Weinheimer ranch and continued to buy additional tracts of land in the eastern part of the county for five years until he had holdings of 6,170 acres, of which more than 2,000 acres (2,216 to be exact) were of the present Weinheimer ranch.

Thomas Doss also began his purchase of ranch land in 1854 and, not counting what he held in partnership with his brother in Doss later, finally owned 3,380 acres. He seems to have been the first of the Doss brothers to turn his eye to the northwestern part of the county. After running their cattle here during summer, they became interested in what is now the vicinity of Doss. They had built a small house near where a fine spring breaks from the hillside. This spring encouraged them to build a dam and they also became interested in building a grist mill. But time was required to grow an abundance of wheat, so in the meantime a distillery was put into operation.

It was in 1856 that the Doss brothers came to Doss to settle. On Feb. 20, 1856, they bought the 320 acres which are now a part of the Alonzo Woerner ranch, better known as the John Friedrich Sauer place.

## Harper ISD Adopts Budget

On Monday August 28th, the Harper Independent School District Board of Trustees held a public hearing in the school district board room. The purpose of the meeting was to discuss the budget and the proposed tax rate for the 2006-2007 school year. The notice for the meeting was posted at school on Friday, August 25, 2006 at 3:00 p.m.

The hearing began promptly at 6:00 p.m. and was attended by seven citizens outside of the board, including the elementary school Principal, Jay Harper and junior/senior high school Principal, Chris Stevenson. Three funds were discussed. Fund 199 General Operations, Fund 240 Food Services and cafeteria and a new Fund 690 Capital Improvements.

Fund 690 will fund the proposed elementary building. Superintendent Perri Whitten explained that construction funds were previously in co-mingled funds. A decision was made to move them into a separate category to simplify tracking.

President Bob Kee informed the group that legislative action had lowered the allowable tax rate and promised districts that governmental funding to them would increase. "It's under the caveat of trust me," he remarked.

Perri Whitten stated that the schools were being forced to compress the rate to 1.2198. However, "the legislature took into account what good stewards we were." (with taxpayers money) "and what we would have generated at 1.50 all along and we got bonus points and they are supplanting that."

The "bonus points" awarded by the government are four cents, bringing the rate up to 1.2598, a twelve cent decrease from last year. The superintendent said "Not taking the four pennies would lose the district \$192,000." She recommended

taking them. (keep in mind the governments generous four cent bonus actually comes out of taxpayers pockets) The legislature will supplant the district with an additional twelve cents to bring the schools funds up to what they received last year.

A woman in the audience asked how the legislature was going to acquire the twelve cents that it is supplying the district with. Vice President of the board, Fred Schmidt explained that the government will impose a gross profit tax on businesses, a tax on margin before profit. After that the hearing was adjourned at 6:52 p.m. and the regular meeting was opened with a prayer. (Seems all tax reform means is pulling taxes out of your back pocket instead of your front! It's less noticeable but it's still YOUR pocket.)

The board adopted the budget for Harper I.S.D. for the fiscal year 2006-07. The tax rate of 1.2598 for the 06-07 school year was adopted without hesitation. Plans presented by Fromberg Associates for the new elementary addition were approved. The Superintendent was authorized to advertise for competitive sealed proposals for site, slab, metal building, electrical, plumbing, HV/AC,

## FISD Finalizes Budget

Dr. Marc Williamson, FISD Superintendent said in a brief interview Thursday that on August 30 the School Board approved the budget totaling \$29,421,460.00. The tax rate of \$1.4384/\$100 is broken down into \$1.3175/\$100 for General Operations, and \$.1209/\$100 for debt service.

Dr. Williamson said this year's rate is a decrease of \$.1516 from last year's tax rate, and he said that next year's budget should rate should decrease about an additional 30¢ if the legislature does not change anything.

Notably, the budget for this year is 15% higher than last year's.

### Miscellaneous Notes on the Ferris Wheel

The Ferris Wheel was the engineering highlight of the exposition and one of the most pervasive, lasting influences of the 1893 fair. The Ferris Wheel was Chicago's answer to the Eiffel Tower, the landmark of the 1889 Paris exhibition. The wheel was created by Pittsburgh, Pennsylvania bridge builder George W. Ferris.

Supported by two 140 foot steel towers, its 45 foot axle was the largest single piece of forged steel at the time in the world. The wheel itself had a diameter of 250 feet, a circumference of 825 feet, and the maximum height was 264 feet. It was powered by two 1000 horsepower reversible engines. It had 36 wooden cars that could each hold 60 people.

The Ferris Wheel grossed \$726,805.50 during its short time in operation, at 50 cents per ride. The profit of approx. \$300,000 was of great benefit toward balancing the books of the exposition.

The wheel was dismantled in mid-1894, after the fair, and reused at the St. Louis exposition in 1904. The original Ferris Wheel was scrapped in 1906. But, the influence of the engineering and entertainment marvel can be readily seen by the large number of Ferris Wheels of various types at fairs and entertainment grounds around the world.

# Letters to the Editor

## To the Editor:

Controversy is great! It stirs the blood, and invigorates the mind. Such was my experience lately, when a long-time acquaintance — a quite friendly one — suddenly said to me, “I hope you don’t support that new Fredericksburg Conservative paper.” Before I was a minute into my response, he left my table for conversation with someone else in the restaurant.

So, the following day I penned a full response and mailed it to him. In the interest of his privacy, I’ll omit personal references in this abbreviated essence of that letter:

To complete my response to your comment, of course I support the new paper. I am old enough to recall a time when Manhattan had five major dailies. My family preferred the Herald Tribune to the Times, and then there was the Journal American, the quintet being rounded out with the Post and Daily News. Both the Trib and the American have been gone for many years now, and one is left with a couple of low-brow tabloids and just one decent paper with, to my taste, a

usually terrible editorial page. Here in Fredericksburg, I understand that there were once two weeklies and a German-language paper to boot, until recently reduced to one. In either big town or small, the loss of journalistic plurality is a sad comment on the public intellect. Where people approach a herd mentality, discourse and debate are stifled and the fresh air breathed into this land by the Founding Fathers, and men of widely varied opinion throughout the centuries, becomes stale.

I support the arrival of any new newspaper in any city or town — no matter what its editorial standpoint. Every such addition is a strong affirmation of our First Amendment. I subscribe to the New York Times even though I strongly disagree with its editorial slant (and especially its often downright vitriolic anti-German drive!) simply because, aside from those annoyances, it is the best American daily I’ve encountered.

The new Fredericksburg Conservative is published by friends, the Treibs, which is one reason I support it. Another is that it was apparently launched in response to corruption in the ranks

of the Republican party here. Thinking I was far from such antics so common back East, I was shocked to encounter them here, and impressed by the industriousness and selfless dedication with which the Treibs and others immediately stepped in to clean house. I was told by your neighbors the [N.] that you are a Democrat, and so you may not know of chicanery attending the Gillespie County Republican convention here in March. Assuming you know [N.] and [N.], they can fill you in on the details.

... [The Fredericksburg Conservative’s] mere existence is something for which local citizens should be grateful. Every new voice, no matter from what direction, is a stimulant of discourse and thought, essential attributes of a vital community.

[N.], if you were to launch a liberal Democratic paper, I would personally support your effort — probably not with money or a subscription, but certainly in principle, and with every word I might write on the topic. Never would I suggest its shutting-down or resort to such slimy stunts as have been employed by some locals against

the FC as tossing stacks of the paper on public stands into the garbage. Such boorishness betrays the root mentality of book-burners and is the antithesis of the ethics which have ennobled America. As a well known quotation goes, “I may disagree with what you say, but I will defend with my life your right to say it.” That, I believe, is a principle which has helped to make America great and free, and I hope it is cherished by us all. Freedom of speech and the press are in short supply elsewhere in the world, even in some so-called democracies, and those guarantees of our First Amendment (“descendants,” as it were, of Zenger’s success in colonial New York) are hallmarks of liberty we must fervently guard if even you and I value the ability to write and speak without “looking over our shoulders.” (Remind me to tell you of my experiences in Prague, when it was still capital of a Communist satellite.)

Congratulations on ..., and thanks for stimulating me to somewhat deeper thought on the Fourth Estate.



## The Faith Based Initiative

(The text of the bill is reprinted below, followed by an analysis written by a local resident.)

Executive Order 13397

Responsibilities of the Department of Homeland Security With Respect to Faith-Based and Community Initiatives  
March 7, 2006

By the authority vested in me as President by the Constitution and the laws of the United States of America, and in order to help the Federal Government coordinate a national effort to expand opportunities for faith-based and other community organizations and to strengthen their capacity to better meet America’s social and community needs, it is hereby ordered as follows:

Section 1. Establishment of a Center for Faith-Based and Community Initiatives at the Department of Homeland Security.

(a) The Secretary of Homeland Security (Secretary) shall establish within the Department of Homeland Security (Department) a Center for Faith-Based and Community Initiatives (Center).

(b) The Center shall be supervised by a Director appointed by Secretary. The Secretary shall consult with the Director of the White House Office of Faith-Based and Community Initiatives (WHOFBCI Director) prior to making such appointment.

(c) The Department shall provide the Center with appropriate staff, administrative support, and other resources to meet its responsibilities under this order.

(d) The Center shall begin operations no later than 45 days from the date of this order.

Section 2. Purpose of Center.

The purpose of the Center shall be to coordinate agency efforts to eliminate regulatory, contracting, and other programmatic obstacles to the participation of faith-based and other community organizations in the provision of social and community services.

Section 3. Responsibilities of the Center for Faith-Based and Community Initiatives.

In carrying out the purpose set forth in section 2 of this order, the Center shall:

(a) conduct, in coordination with the WHOFBCI Director, a department-wide audit to identify all existing barriers to the participation of faith-based and other community organizations in the delivery of social and community services by the Department, including but not limited to regulations, rules, orders, procurement, and other internal policies and practices, and outreach activities that unlawfully discriminate against, or otherwise discourage or disadvantage the participation of faith-based and other community organizations in Federal programs;

(b) coordinate a comprehensive departmental effort to incorporate faith-based and other community organizations in Department programs and initiatives to the greatest extent possible;

(c) propose initiatives to remove barriers identified pursuant to section 3(a) of this order, including but not limited to reform of regulations, procurement, and other internal policies and practices, and outreach activities;

(d) propose the development of innovative pilot and demonstration programs to increase the participation of faith-based and other community or-

ganizations in Federal as well as State and local initiatives; and

(e) develop and coordinate Departmental outreach efforts to disseminate information more effectively to faith-based and other community organizations with respect to program changes, contracting opportunities, and other agency initiatives, including but not limited to Web and Internet resources.

Section 4. Reporting Requirements.

(a) Report. Not later than 180 days from the date of this order and annually thereafter, the Center shall prepare and submit a report to the WHOFBCI Director.

(b) Contents. The report shall include a description of the Department’s efforts in carrying out its responsibilities under this order, including but not limited to:

(i) a comprehensive analysis of the barriers to the full participation of faith-based and other community organizations in the delivery of social and community services identified pursuant to section 3(a) of this order and the proposed strategies to eliminate those barriers; and

(ii) a summary of the technical assistance and other information that will be available to faith-based and other community organizations regarding the program activities of the agency and the preparation of applications or proposals for grants, cooperative agreements, contracts, and procurement.

(c) Performance Indicators. The first report shall include annual performance indicators and measurable objectives for Departmental action. Each report filed thereafter shall measure the Department’s performance against the objectives set forth in the initial report.

Section 5. Responsibilities of the Secretary.

The Secretary shall:

(a) designate an employee within the department to serve as the liaison and point of contact with the WHOFBCI Director; and

(b) cooperate with the WHOFBCI Director and provide such information, support, and assistance to the WHOFBCI Director as requested to implement this order.

Section 6. General Provisions.

(a) This order shall be implemented subject to the availability of appropriations and to the extent permitted by law.

(b) This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by a party against the United States, its agencies, or entities, its officers, employees, or agents, or any other person.

“1. (a) The Secretary of Homeland Security (Secretary) shall establish within the Department of Homeland Security (Department) a Center for Faith-Based and Community Initiatives (Center). “

The establishment of a Center for “faith-based” — i.e., churches’ — initiatives within the Department that includes the FBI, CIA, air and other transportation security units, etc., seems strange indeed. What do soup kitchens have to do with security? Would such “initiatives” more properly be included in, say, something like “Health and Human Services?” Or has the ultimate function of a “faith-based and community initiatives” center more to do with control than with charity?

“1. (c) The Department shall provide the Center with appropriate staff, administrative support, and other resources to meet its responsibilities under this order. “

The Center for Faith-Based and Community Initiatives will be staffed by the Department of Homeland Security. Will FBI or CIA men be ringing the doorbell at your parsonage, rectory or manse?

“3. ...the Center shall: (b) coordinate a comprehensive departmental effort to incorporate faith-based and other community organizations in Department programs and initiatives to the greatest extent possible;”

### UN Rights of the Child U.N. Treaty Trumps Parental Rights

Could a 10-person panel of foreign nationals dictate, with the full weight of U.S. law, how we raise our children? This idea seems far-fetched, even ridiculous, but, unfortunately, it is possible.

The problem stems from the United Nations Convention on the Rights of the Child, which has been adopted by

192 nations. The treaty creates civil, economic, social and cultural rights for every child. The Clinton administration sought ratification, but the treaty was not approved by the U.S. Senate because of opposition from senators who were concerned it would undermine parental rights.

For example, the convention gives children autonomy regarding the school they attend, the friends they have and the activities they choose. If there is a disagreement, the parent's decisions could be reviewed by a third party. Consequently, parents could be subject to "identification, reporting, referral, investigation, treatment and follow-up."

Many people are probably asking the question—if the Senate didn't ratify it, why is the convention still a

problem for the United States? Unfortunately, this is not the end of the story because the U.S. court system has been incorporating the treaty steadily through a doctrine called "customary international law." This is where U.S. courts look to foreign courts and other international treaties to derive its interpretation of the U.S. Constitution.

In the 2004 case *Roper v. Simmons*, a majority on the U.S. Supreme Court noted that the execution of juvenile offenders violated several international treaties, including the U.N. Convention on the Rights of the Child, and stated that the overwhelming weight of international opinion against the juvenile death penalty provides confirmation for the court's own conclusion that the death penalty is disproportional punishment for offenders younger than 18.

Additionally, a change in the makeup of the Senate could result in the ratification of the treaty. The consequences of these actions could be devastating for the American family because it would mean that any state law relating to education, the family, adoption and dozens of other issues could be nullified by a judge.

Decisions interpreting the treaty in other nations could be relied on by our courts. An example of how this could unfold is occurring in Belgium today. A couple in Brussels is being threatened with criminal neglect for educating their children at home, and the Belgian authorities are using non-compliance with the convention as a legal argument to force the family to stop homeschooling. As reported by WorldNetDaily, the only response from the Belgian minister of education,

Frank Vandenbroucke, came through a spokesman who said in a local newspaper that in Belgium homeschoolers must sign a document that requires them to follow the protocols of the U.N. convention.

"These parents have not done this. This is why the ministry has started an inquiry," he said.

It remains to be seen whether the Belgian courts, and potentially the European courts, uphold the position of the Belgian government. A ruling against the homeschooling Belgium family could have negative ramifications in the United States.

If the treaty is ratified, because of the way the U.S. Constitution is written, the convention would become the supreme law of the land. The U.S. Constitution's supremacy clause re-

quires that "all treaties made, or which shall be made, under the authority of the United States, shall be the supreme law of the land." The U.S. Congress and state legislatures could not override the provisions of the treaty.

This scenario should remind us that we need to remain vigilant in defense of our liberty. In the short-term, it means that the appointment of judges who will not look to foreign courts for guidance is one of the ways the scenario above can be avoided.



censure and reproach from political cretins and apostate associates. Let me tell you how I know this.

In late 1999, as Sheriff of Sioux County, I set up an armed militia, or as it is more likely to be called, a Sheriff's Posse. Y2K was rapidly approaching and I reasoned that in the event that major civil disorder should occur, and cause something of the nature that we witnessed in New Orleans, we should have an armed force ready to help oversee the safety and welfare

of the people in my county. I already knew what the people of New Orleans learned, that the feds couldn't be trusted to differentiate between criminal marauders and law-abiding citizens.

The statutes of the State of Iowa provide the authority for the sheriffs' of the state to summon the power of the county, and to deputize citizens to assist them in carrying out their duties. I had in my county 400 solid citizens to whom I had issued concealed weapons permits. I knew these people and trusted them implicitly. Each of these individuals had undergone a thorough criminal background check and they were of unimpeachable character. Sensing that I had a great pool of armed and intelligent people to select from, I contacted these permit holders, both men and women, and asked if they would be willing to serve as members of a sheriff's posse.

Except for a handful of elderly citizens who heart brokenly told me that they felt they were too old to function effectively as a posse member, all of those whom I contacted accepted willingly and with enthusiasm. I advised those who felt that their more advanced age would prohibit their service that there were many things that they could do beside just carry a gun and confront outlaws, and they signed up also. Now all hell broke loose, but before I get into that I want to give you some additional background.

I have served forty-three years in law enforcement. And if you count three years as a military policeman in the occupying forces in post war Berlin. Germany I have a total of forty-six years of law enforcement service. I served fifteen years as a municipal police officer, and then I ran for the office of county sheriff, and was elected. In 1977 I was sworn in to the first of seven consecutive four-year terms of office. During my twenty-eight years as sheriff I was able to build an office of considerable stature with capabilities and abilities, which had been heretofore lacking in the office. In 1979 I was elected "Iowa Sheriff of the Year" by the Iowa State Sheriffs' and Deputies' Association, and I served for eight consecutive years as a governor's appointee to the Iowa Board of Corrections. The solid reputation of the office was widely known, and I received yearly hundreds of inquiries and requests for applications for positions on the staff. All of this counted for nothing when the crap hit the fan over my formation of a sheriff's posse.

Anyone familiar with county level politics will tell you that if a county officer succeeds and makes his office one of admiration and respect this will almost always engender the animosity and jealousy of other county offices, and particularly that of the county board of supervisors, or as they are called in some states the board of commissioners. I can truthfully say that there was never a time during my entire twenty-eight years as sheriff that the board of supervisors did not consider me to be other than an enemy to be dominated and controlled. They used every imaginable tactic throughout the entirety

of my service to impede, denigrate and hold back the progress of my office. The more accolades the sheriff's office received for service and excellence the worse the envy and animosity became. The only thing that saved my political hide during my first five terms in office was that my office was very effective in protecting the lives, rights and property of the citizens and therefore had excellent public support. We will see that this also changed through the years as the ethics and morals of the new generation transmuted. But, while this public support held and was consistent the board had to be covert and underhanded in their effort to undermine the sheriff's office.

Their chance finally arrived with my formation of a sheriff's posse. And

they immediately seized their opportunity to vilify the sheriff. In open board meetings, with media present, they never missed a chance to refer to me as a wild-eyed and dangerous nutcase who was assembling a lynch mob. They would invite me to their meetings on the pretense of discussing office issues, and then call the TV stations with anonymous tips that something big was going on with the sheriff's office that was worthy of media coverage. When I would arrive at the meetings, invariably the TV cameras would be already in place. The pretext use to lure me to the meeting would be forgotten, and board members would bait me with inflammatory comments. And then as the TV cameras rolled and the reporters scribbled frantically on their pads the good times would roll, for all of course, but me. They said in one of their meetings that, "I had left the farm." Meaning of course that because I was concerned enough to plan for the safety of the citizens in the county by assembling a Sheriff's Posse that I had taken leave of my senses.

These events generated media frenzy and the comments made by board members were appearing in publications from coast to coast. The Wall Street Journal, for whom I had previously had some respect, ran a demeaning article, in which they highlighted the board's "left the farm" comment, on their front page. The media sensationalism and hysteria became so intense that my heretofore-public support began to wane and dissipate. The Board was elated and poured it on with intensity. Every comment that I made to the media was either taken out of context or edited. I was almost always misquoted and the so-called news articles in the area papers were

no more than biased editorials by young and dumb reporters. I finally quit making comments and public statement, and I refused to meet with, or talk to, the print or electronic media people. Mind you all of this because I cared enough about the people, whom I served, to want to protect them and ensure their safety

and secure their constitutional rights in times of crisis.

But the board wasn't through with me yet. They smelled blood in the water, and like the sharks that they were they intensified their smear campaign and morphed it into a crusade to get rid of me. They surreptitiously approached my staff people and were able to assemble from among them a cadre of disloyal deputies to help them with their cause. I was inundated with union grievances, and there were many outright and deliberate violations of my administrative policies. It became so bad that I had to demote an administrative Lieutenant and reassign him to patrol duty. The board immediately took up his cause, and once again the media frenzy was re-ignited. The board entertained the deputy at their meetings and commiserated with him in open meetings to which I had not been invited.

Interviews with the Lieutenant were set up during which he actually cried in front of the TV cameras. He unashamedly blubbered that the reduction in his salary was starving his family, this even though he was making \$50,000.00 a year plus \$21,000.00 in benefits after his demotion. The bleeding hearts were all over me despite the fact that the Iowa Code made provision for just such a demotion. By statute the sheriff has the right to politically appoint his first two deputies and the appointments, if made, may be withdrawn without cause. I had cause, but this made little difference as the people, were beginning to believe, due to a pattern of frequent repetition, the manure being shoveled by the board, the media and the shameless deputy.

There is a lesson to be learned from this, the media is never interested in the truth of a matter or even in an impartial probe of the facts of a situation. They thrive on controversy and sensationalism and will go to great lengths to promote it if it is not present. They choose a side and then expend all of their energy making sure that their side wins in the realm of public opinion. They never used my name in a sentence without preceding it with the word controversial. I was routinely referred to as, "controversial sheriff Jim Schwiesow". We have been programmed to be a nation of sheep and the concept of justice is now completely warped. People will cry and sob over the plight of criminals, killers, prison inmates, and insubordinate employees, and ignore the damage inflicted by these people.

Thirty years ago people would have looked at the circumstances of my situation, said hogwash and moved on with their lives. Now, however, the continual caterwauling and carrying on took root in gullible minds and enabled the board and the local party officials to promote the candidacy of the disloyal and shame deficient former Lieutenant for a run for the sheriff's office. The problem was that I still had a year and a half to serve on my term of office. If they were to be rid of me this had to be dealt with.

One day one of the board members called me and asked me to meet him in a restaurant in a town situated in a neighboring county. I was suspicious, but could not resist hearing of what kind of further skulduggery the board was up to. After some phony preliminaries, this supervisor got down to business and made a proposal that he felt I wouldn't be able to resist. He told me that the board would be willing to buy out the remaining year and a half of my term of office for \$150,000.00. I said to him that I believed this to be illegal, and he replied that the board had consulted the county attorney (another story here) and that she had informed them that it was entirely legal. In order

to ascertain if he was acting on behalf of the entire board I asked him to put it in writing.

The following day he appeared at my office and asked to speak with me privately. He had with him a handwritten proposal the content of which was that the board would pay me \$150,000.00 either in one lump sum or in installments if I would resign my position as sheriff. The supervisor advised that the board would make a public release stating that I would be a paid (but inactive) consultant in exchange for the money. I said to the man, "Let me get this straight, you are willing to soak the taxpayers of this county an extra \$150,000.00 by paying me and a newly appointed sheriff a total of \$300,000.00 over the next year

and a half?" He replied, with a look on his face, which was supposed to make me believe that my statement had hurt his feelings, that they were just being kind and offering me an early retirement package. I said, "Sure you are, now I'll tell you what I am going to do, I'm going to serve out every day of every week of every month of my term of office." And with that we parted company, but not before he said to me, "You are being foolish, you could have used the money to buy that land in Arizona which you want."

So there you have it, a sad true tale of the sheriff who wanted to set up a militia to provide for the safety and well being of those he had sworn to protect. I might add that I did set up a militia, despite the board of super-

visors and despite a stupidly hostile media. I had calls from states attorneys and sheriffs' from across the country with statements of support and inquiries as to the language of the state law, which allowed me to do so.

The last time I did a google search there were many, many pages documenting the results of my assertion of my right to assemble a militia. But, after eight long wearying years of being pummeled by the j----- on the board and the j----- in the media I had simply had enough, I retired. The disloyal and faithless former Lieutenant, whom the board could control and direct, was elected sheriff and is currently mired in some controversy of his own. A controversy not born of a commitment to that which is right or

for dedication to his constituents, but a controversy wrought by ineptitude and the inability to control his staff.

And what of the Sheriff's Posse, does it still exist? Now, you know better than that don't you. Of course you do. The Posse was disbanded forthwith by a sheriff not beholden to his constituents, but to five elected potentates possessed of no other qualifying attributes than being of age and having an innate sense of their own importance.

**Trans Texas Corridor**  
America's infrastructure fire sale

The Chicago Skyway Bridge is a 7.8-mile toll road built in 1958 to connect the Dan Ryan Expressway to the Indiana Tollway. In 2004, the facility was leased for 99 years, for a one-time payment of \$1.83 billion, to the Skyway Concession Company, LLC, owned by Cintra Concesiones de Infraestructuras de Transporte S.A., and Macquarie Infrastructure Group. This same consortium won a 75-year lease for the 157-mile Indiana Tollway for \$3.85 billion.

Cintra is a Spanish company that has 21 similar highway projects in six countries. Macquarie Infrastructure Group is a wholly owned subsidiary of Macquarie Bank, an Australian corporation with assets in excess of \$100 billion.

Cintra has also formed a consortium with Zachry Construction Company in San Antonio, Texas.

In December 2004, the Texas Transportation Commission selected this consortium to develop the Trans-Texas Corridor. The proposal included a bid of \$1.2 billion to build and oper-

ate the first segment of this facility as a toll road. Zachry Construction Company has invested heavily in political campaigns of key Texas officials.

The Trans-Texas Corridor is a member of the North American Super-Corridor Coalition.

Greg Carey, managing director at Goldman, Sachs & Company, told the Texas Transportation Forum last June, that this method of financing should not be limited to highways, but should include airports, bridges, tunnels, parking facilities, ports, rail, water and sewer systems, power facilities, hospitals, government-controlled liquor stores and "... anything else that produces revenue."

The American Water Works Company, a subsidiary of Germany's utility mega-corporation RWE, already provides water to 18 million Americans in 29 states.

Carey also told the group that all but 14 states had already changed their laws, or were now considering legislation, to allow this "international" financing of public infrastructure.

This relatively new method of financing infrastructure has excited government officials who see these public/private partnerships as win/win solutions. Government gets an infusion

of cash and is relieved of the burden of daily operations. The private sector is eager to invest in long-term projects that promise a payback of as much as 61 times the investment.

But the users don't win. They get to pay a new tax in the form of tolls, in addition to the gasoline tax that is supposed to provide highways.

The devil, of course, is in the details. Each deal is governed by a contract between appointed government officials and corporate big wheels. There is little or no oversight by elected officials. Each contract determines such things as maintenance, minimum services, prices charged for services, concessions offered along the tollway and every other aspect of the venture. If the public that depends upon the infrastructure facility doesn't like the performance of the contractor, to whom do they turn for recourse? Elected officials are out of the picture; appointed officials are bound by contract.

The users of the facility are left with whatever they get from the contractor, which inevitably includes gasoline and concession prices that are much higher than those found along non-toll highways, where competition governs prices.

In anticipation of the Trans-Texas Corridor, the Kansas City Southern Lines set up a Mexican subsidiary to purchase the National Railways of Mexico, with 2,600 miles of track that reaches to Mexico's ports in Veracruz and Lazaro Cardenas.

These ports are owned by another international mega-corporation: the Chinese Hutchison Whampoa Limited. This company has globally strategic locations in 21 countries throughout Asia, the Middle East, Africa, Europe and the Americas, and operates a total of 251 berths in 43 ports, including the ports at both ends of the Panama Canal.

The so-called "free trade" enthusiasts have no problems with this international ownership of strategic infrastructure. In fact, it is the essence of "globalization" through public/private partnerships. Enthusiasts claim that this transfer of public infrastructure to private partners is the free market at work.

But it is a process that is rapidly erasing the concept of national sovereignty. Is it smart to allow America's crucial infrastructure to be controlled, if not owned, by foreign companies? Kenneth Orski reports that one of these toll projects in Stockholm has been used as a demonstration project to show that pricing can be an effective way to decrease automobile use and force public transit use.

Are we empowering these public/private partnerships to make and enforce public policy? Are we removing elected officials from responsibility and accountability for infrastructure? Are we building a trap that will ultimately subject American citizens to the whims of the global elite? Are we making a big mistake, selling American infrastructure to the highest international bidder?

Grandmother ("Oma") Hildebackh ran a bakery in Germany, and taught Jacque' the fine art of confectionary. Grandfather Beilharz educated and coached Jacque' through the years in fine dining establishments, and informal home entertainment.

At age 17, Jacque' managed her first restaurant. It was a New York franchise with epicurean gift shop, delicatessen, and catering service, all under her care. This is the European flair that Chef Jacque' brings to the Cottage Cafe'.

Chef Jacque' is becoming well-

known for her Chef's Tastings, petit portions of a variety of dishes artfully prepared for each client's taste.

The Cottage Cafe' is not just a place to eat, but it is a dining experience. Some clients come to celebrate special events, such as anniversaries, and others are regular customers. The Cottage Cafe' also specializes in private parties and functions.

Menu items include a \$10 Steak and Salad, a \$12 Brie Cheese Board, and 3, 5, and 7 Course Chef's Tastings.

entered into an agreement that they would share the land on the Threadgill, each of them having taken out a preemption certificate for 160 acres. These 320 acres were a part of the present Emil Lange ranch.

Consequently, the founding of Doss occurred when the Doss brothers entered into a three-way agreement with William C. Thomas to build a saw and grist mill on the Threadgill a little below the fine springs that furnish an abundance of water to turn the wheels of the mills. This they began to do in the summer of 1856. The Doss brothers had been influenced by the Mormons, whose settlement was close to their land that they owned, southeast of Fredericksburg. The Mormons had a flourishing saw mill business on the Pedernales and had supplied most of the lumber for Gillespie County. The Mormons had branched out to Doss on what was later known as Mormon Creek but their sojourn must not have lasted long. In spite of the crude rustic machinery this sawmill took a great part in serving the people of the community.

A certain J.D. Robinson seems to have settled nearby and opened a general merchandise store, for we find a record of May, 1861, of the purchase of all his "stock of goods, wares, grain, groceries, merchandise, etc." by John E. Doss, which indicates that they had a general merchandise store in connection with their mill. He had slaves on their plantation near Fredericksburg. Since they built such a beautiful home on the hill south of their distillery, a show place of the entire community, displaying the remarkable workmanship of the German men such as August Steiness, who was a skilled craftsman at sawing and lumber work, indications are that slaves filled in at the Doss mill.

As though good fortune had reached its climax in the fall of 1859, the worst flood in the history of that section arose, destroying their dam and almost washing away the saw and gristmill and later in 1859, fire completely demolished their beautiful house.

The Doss Brothers Are Gone

From then on the mill saw a shifting of partners and a change of hands several times. William Thomas sold his interest in the mill and land to the Doss brothers only a little more than a year after the partnership had been formed. A year after that a certain William Wallace bought into their firm.

Arrival of the Germans

John Doss died some time before 1864. His heir was William C. Doss. In that year, August Steiness, who had worked for the Doss brothers, bought the Doss mill for \$10,000 in Confederate money. Enthusiastic over his purchase, Steiness immediately began making preparations to develop a great community. He tore away the old distillery and improved the gristmill by making additions. Then he built a store and added a room to the old house to be used for a post office, where those coming and going to Cherry Springs would bring the mail and leave the mail for the whole community. In 1862 he made the mill both a flour and corn mill. Steiness seems to have died soon after he became the owner of the mill. His widow, Mary Steiness, sold the plant to William Lange on May 16, 1866, for \$530 in good U.S. currency. The new owner was from Bexar County and little did he and his

family realize the vast fortune they had acquired soon after they had arrived in San Antonio. They made their home here, after landing at Indianola following a three month voyage from Bernstein, Germany (over the most surging waves that tilted the ship until the sails

came, filling the streams and increasing the pressure against the newly built dam until its wall gave way and all rocks and sand scattered in the rushing stream. Their dam was gone. This was a most distressing disaster and certainly disheartening, not just to the Langes, whose endeavors had become about exhausted, but to all the surrounding country depending on the mills for their breadstuff.

In 1878, at the time when possibly all dreams and ambitions were realized and crops harvested, F. W. Lange died. He had three full glorious years after the completion of his dam and at the height of his happiness and of his

approval of Update 78 and the board approved.

It was brass determination and iron clad persistence that stirred the Langes on to build another dam. They started work in 1872 and the new dam was completed in 1875. Buchmeier, a stonemason, who lived eight miles north of the mill did his utmost to prove his skill in building a dam that would not break. Their efforts were not in vain, for it is one of the most remarkable pieces of craftsmanship in the country, built to serve through centuries. Today the old mill and dam are in perfect state of preservation and visited by many tourists the year around.

Coming of the Germans

(The Lange family couldn't believe their eyes when they landed on the shore of Indianola and actually walked on the soil of earth again.) Surprised as they were when they landed from their voyage, they were even more surprised when they arrived at their new home. It was a far more flourishing business than they had dared to dream of; even in this promising new country. With the mill well known all through the surrounding country and its products being so favorable, the Langes immediately realized more power was necessary to handle the business. A larger dam was built, and when the dam was completed another obstacle arose. There was too much power and the shaft of the overshot wheel was broken. A turbine wheel would solve the problem and the Lange boys left for San Antonio where, after a few days shopping around, such a wheel was purchased from Beyers Mill and the boys started their long trip back home. It took

business, he left the grist mill as a token of his life's struggle to his son, Julius.

In 1896 Lange's Mill was first officially made a post office and was then known as Lange's, Texas, with John Kasper being the first authorized mail carrier riding horseback twice a week to carry the mail to and from Cherry Springs, where it was left by a stage coach. In 1904 a daily mail route was installed and the end room of the old house still served as the post office. In 1915 Lange's post office was cancelled and was given to Doss valley.

Conclusion of Doss History

Mrs. Crenwelle's historical recounting concluded by saying that the settlers succeeded because of their faith in God, their hard work, and their respect for the land. The present descendants of Doss, and the newcomers, are walking in the light of their legacy

Mission Trip to Russia

Having just returned from Russia, I am still thinking in my own broken Russian, enjoying the memories of a wedding that for Russians is often a three day event, including lots of food, drink, and music. My mission trip was wrought with trials and trouble, but in it all the Lord had a plan, and He fulfilled it. Flights canceled due to weather, one flight returning after an engine problem, lost luggage, sickness and more, left me in a great place to trust in the Lord. All roles were reversed..., many years ago I went as a missionary to Russia and helped to plant churches. The Russians were truly drawn by the Holy Spirit to know Jesus in great numbers and a great revival broke out. The people of Russia saw Americans and missionaries in a very positive light and really depended on us to help them. Well, on this trip I was truly depending on them. When finally arriving in Russia two days late, I found that my luggage had not followed. All the clothes, medicine, wedding gifts etc., were lost.

Mama Valya made me a pair of dress pants, Pastor Randy loaned me a shirt and tie, and the whole wedding went just as planned. I was treated with teas, kefir, and garlic for my ailments. My friends took me to the forest for some fresh air and we picked fresh raspberries and mushrooms. I enjoyed reunions with friends made as far back as 1993 when I first went with my Pastor Rick Amato and his wife Susan. My interpreter Dennis Ershov who now owns his own trucking business brought his daughter Yana to see me. I have the privileged of being Yana's Godfather. Yana is now five years old and reading well, she speaks English as well as Russian and is unusually intelligent. After about ten minutes of conversing in English, Yana politely gave me permission to speak in Russian. It was all very heart touching, to see the relationships that have grown from those first efforts to reach these precious people with the Gospel of Jesus Christ.

There were some very different attitudes than those I encountered back in 1993. There is a great surge in anti-American nationalism and antisemitism. When Russians look ahead, they feel that they are on a roll. Thanks to sky-high oil prices, Russia is flush with cash. It has paid off much of its foreign debt ahead of schedule. Pensioners are no longer afraid of starving to death in the winter, soldiers get regular pay and there is a general sense of security. The anti-American nationalism so palpable in Russia today is rooted in the 1990s, the decade of Boris Yeltsin, whom many Americans credit with ending Soviet totalitarian-

ism and introducing the country to democracy. Russians have a different take on those years. They remember the chaos; the economic contraction; the extreme poverty; the robber barons who, with the connivance of the government, made billions after taking over state-owned industries at bargain-basement prices; and the Yeltsin family's rampant corruption. Rightly or wrongly, they associate these bad experiences with the United States.

Interestingly, the Russian Orthodox Church is also a great source of nationalism, and its leaders make no bones about it. Many leaders of the Russian Orthodox Church actually are happy that Russia was not granted membership in the World Trade Organization, fearing that globalization will reduce Russia's independence, contaminate its culture and allow foreigners to control its natural resources.

The events in the Middle East

have also stirred the latent embers of antisemitism that has historically run deep in Russia's history. The pogroms, which were village by village holocausts, are almost unknown history to the average Russian, but the attitude of blaming the Jews for nearly everything imaginable still is very much alive and increasing with rabid ferocity. As one young man Ruslan stated his case he made the statement that the Jews were forming trade partnerships in his city and holding meetings. He said he was glad for one reason, "because we will know where to find these people when we go to get them."

Needless to say it was uncomfortable to be confronted with these attitudes, while at the same time it is a privilege to be able to participate freely in these conversations. The respect that has been gained by building long term relationships has kept the doors open to our hearts and as ideas were exchanged I left confident that all is not lost.

Next mission? Looking ahead I am challenged to return again, hopefully with a team of like minded Christians. Our dear brothers and sisters in Jesus all over the world need our encouragement and participation to give them hope. Are we up for the challenge? **Health Care**

By John Merrifield, Professor of Economics Director, Entrepreneurial Conservatism Institute September 4, 2006

The just-released "Code Red" report alleges a health care crisis in Texas because 25.1 percent of us are without health insurance. The path to tyranny and poverty is paved with good intentions and misleading statistics.

"Code Red" assumes that a 25.1% 'uninsured rate' means 25.1% cannot purchase health care, which is unacceptable, and that government intervention is the solution, not the problem. Credible leadership is needed to address each of those questionable assumptions and avert a renewed government assault on our prosperity, liberty, and the well being of the sick and injured.

The uninsured are a constantly changing set of people. The much more informative, rarely published number is the long-term uninsured. Many counted as part of the 25.1% are briefly between jobs, and others have simply made an economic decision to not spend their limited funds on expensive health insurance and pay out of pocket, if necessary. Based on a quick Internet search, I estimate that only about 10 percent of Texans lack non-emergency room access to health care for an extended period; a much less scary number than 25.1%. We need to demand that our leaders - the people with their hands in our pockets

— deliberate on the basis of relevant numbers, not sensationalist, misleading numbers.

With a clearer picture to work from, we can discuss the underlying assumptions. Many people equate 'no insurance' with 'no access' because health care and health insurance has gotten very expensive. Because of past government interventions, prices have shot up because hardly anyone directly pays for their own health care. Do it doc, someone else is picking up the tab. Now that our policies have driven up the prices to those outside the 'someone else will pay' club, many people demand additional government intervention to address the impact of that.

Many assume that the earnings of the successful should be taxed to pay for care for those who do not earn enough to buy it for themselves; that those who earn little should not have to rely on charity. As we expand 'rights' to the earnings of others, we move towards socialism; certainly with good intentions, but the effects are the same. Liberty and prosperity retreat across the board. Even our poor are better off than the average citizen in the socialist paradises of North Korea and Cuba.

Do we want the same political process that created 'Nation at Risk' quality public schooling to have a larger role in the delivery of our health care? In so-called single-payer, Government-controlled health care systems around the world, patients have lost freedom of choice, and the sick are literally dying while on wait lists for critical care. It's going to take exceptional leadership to separate sympathy and politics.

Lupe was often seen in the kitchen or at the cash register wearing her apron, working hard. She knew many of her customers by their first name, knew what they usually ordered, and chatted with them. Frequently her grandchildren visited the restaurant, adding a family atmosphere.

Increasingly, as medical technology advances, it is impossible to promise universal access to everything that we know how to do. Attempting to do so, or just failing to face this economic reality, will reduce the efficiency of the entire system. That means longer wait times, higher prices, and lower quality care.




# Home Project: The family builds a family computer




We laid out all the components. You can see some of the children standing ready to assist



The motherboard is still in the box, and that is where we installed the CPU, the thermal grease, the cooling fan, and the memory. According to one web site, that method gave us more room to work. You can't see it in the picture, but we had the windows open to increase the humidity to decrease the probability of static electricity, which kills computers. Be sure to ground yourself well each time before touching the computer.



We installed the motherboard in the computer case, where we had already installed the power supply and an extra cooling fan. The video card was not yet in, and none of the cables from either the power supply or the case were connected, as you can see. Connecting all those cables, and figuring out where to connect them, took more time than anything else. Later on we installed the hard drive and DVD drive,



Uncle Stephen helps set up the network. He has plenty of eager assistants. We needed the new and old computers networked so we could copy files from the old to the new computer. There was a lot of data and it took a long time. We still have not yet transferred all the files.

## Pointers

If you are going to purchase a computer, here are a few things to consider.

First, you need to decide why you need a computer, and what you want to accomplish with it.

It's just a tool to accomplish a task.

Do you want to surf the internet? Make online purchases? Send and receive email? Write letters? Balance your check book? Conduct your business? Play games? The answers to those questions make a big difference in what you buy.

Then you need to decide what computer you want, and what you can afford, which are generally two different things. Probably the best way to decide is to talk to someone who knows a lot about computers. For example, you could call Scott Mills at PC Solutions, who is a personal friend, and a computer dealer and repair person in this area. His number is 990-6679.

Then decide who or what company will give you the best deal for what you need. Will you need technical expertise every now and then? That's a big consideration when you are going to decide where to buy your computer. If you buy a mail order computer, or from a big, impersonal store locally, who will help you when you have a question or a problem? If you buy from someone like Scott, you can always call him, or even have him come over and help.

I have enough friends and relatives who are computer savvy that I was able to buy components from a number of different places, and put them together, and then ask for help for things that did not work.

If you buy online, search for buyer evaluations of the company you are considering.

I made purchases from PageComputers.com, NewEgg.com, and zipzoomfly.com all of which have

received good reviews from others who purchased from them. I do have a complaint about PageComputer. I purchased several incorrect items from them (it was my fault--I didn't pay close enough attention to what I was purchasing, and bought the wrong items), and need to return them, but they do not have a customer service telephone number to call, and they have not answered the latest emails I sent to them asking to help me return the items. So far I'm stuck with one rather expensive item: an AMD 64 Athlon X2 Socket AM2 3800+ CPU with heatsink. I'll make anybody a good deal who wants it, plus give you whatever Arctic Silver 5 thermal grease that I have left.

Some other questions to ask about online purchases: How much is the shipping? What is their return policy, and how much do they charge for a restocking fee, and do they take returned merchandise that has been opened? How many days do you have to return

merchandise? How long will you have to wait for the merchandise to arrive?

If you decide to buy individual components or software online, consider using one of the price comparison engines. One way to find them is to go to your favorite search engine, such as Google or Yahoo, and type in the words: lowest price, and then the name of whatever you want. Be aware that there are scam companies and individuals out there, maybe even quite a few of them, who will take your money and make your life miserable. Be careful where you shop. Be even more careful when buying software, or you will end up buying something that is a pirate copy made in Eastern Europe.

Several useful price comparison websites are PriceGrabber.com and

I can't explain why I'm so relentlessly passionate about the pro-life cause, except to say that I know it is what the Lord put me here to do. One Sunday I was sitting in church, and suddenly, all I wanted to do was write something that would convince the world to end the tragedy of abortion. Almost ten years and more than ten million abortions later, I still feel called to write. It is the most difficult thing I do.

After seven years of writing, I met Jim and Debbie Locander of Choose Life Ministries. I had never been to an abortion mill; and, frankly, I did not ever intend to go. Debbie kept asking, and I finally ran out of excuses and conceded. The appointed morning arrived, and

I kept reminding myself that my job was to write; but, for some reason, I had to keep going to the mill.

Instead, I felt the Lord was leading me to invite other members of our church to go out to New Women's Clinic on a monthly basis. Since we began our Saturday outreach on January 21, we have undeniably seen the Lord's blessing. In two month's time, I have at last personally witnessed the Lord rescuing not one, but three babies. One of the moms we met last week even attended our church this past Sunday, and she was greatly impacted by the message. During this same two-month window, our nation has also witnessed the unanimous Supreme Court ruling in favor of pro-life demonstrators, and the banning of virtually all abortions in South Dakota. Thank you, Jesus!

I believe we are at a defining point in history, a time in which the Lord is empowering Christians to speak up for those who cannot speak for themselves. Our response to this opportunity will literally determine the future of America. We may not have another decade and 10,000,000 more lives to lose. At any rate, the souls of the mothers and fathers, their friends and family, the clinic staff, and the abortionists are of far greater worth than a few extra hours of sleep. :)
